Information

Retroactive customs clearance of pets

This information letter provides information on the retroactive customs clearance / declaration of imported pets.

The **practical procedure** for the customer / pet owner in the case of retroactive customs clearance is explained under **point 2**.

The legal basis and the correct procedure for importing pets to Switzerland are brought to mind under point 1.

1 Border crossing with pets

According to Art. 21 and 24 of the Customs Act, goods must be brought immediately and unaltered to the nearest customs office and be declared.

Article 19 of the Regulation on the Import, Transit and Export of Pets (EDAV-Ht) stipulates that when importing or transiting pets for which a pet passport, veterinary certificate or permit is required, the keeper or authorized person must present the pet, the pet passport, the veterinary certificate or permit to the customs administration.

This means that the pet owner or the authorized person must always import pets at a **designated border crossing point during the opening hours** and **declare them to the customs authorities**. This also applies, when the value of the pet is below the value exemption limit. Retroactive registrations are generally prosecuted and result in a fine.

2 Retroactive customs clearance - practical proceedings

Requests for **retroactive customs clearance** of pet animals must be submitted without exception to the Pet Competence Center of the FOCBS (KoHe). The provided notification form must be used for this purpose:

Requests must be submitted to the KoHe by e-mail: KoHe@bazg.admin.ch.

The KoHe staff will contact the client as soon as possible. Due to the high volume of work, this may take some time. **The original of the pet passport must not be sent in to the KoHe.**

The staff of the Pet Competence Center will contact you as soon as possible.

The Pet Competence Center will collect the owed value added tax. We reserve the right to initiate penal proceedings due to infringement of affected legal decrees.
