Approximately 2,200,000 people, 1,100,000 cars and 21,000 heavy goods vehicles cross the Swiss border every day. On a daily basis, FOCBS employees collected and found:

- CHF **66.6 million** in receipts
- **118** counterfeit products
- **58** people who were wanted or had an arrest warrant issued against them
- **5** forged identity documents
- **10** prohibited weapons
- **3** kg of drugs
- **143** cases of illegal residence
- **21** consignments of medications or doping preparations
- **29** defective lorries
